## CLEANSING STATEMENT AND APPENDIX 3B

Deep Yellow Limited (ASX:DYL) (**Deep Yellow** or **Company**) confirms that it has today issued 1,973,571 ordinary fully paid shares (**Shares**) under the shortfall placement announced on 3 July 2019 to qualified institutional investors at \$0.31 per Share to raise \$611,807 (before costs).

The Shares are in a class of securities quoted on the Australian Securities Exchange (**ASX**). An Appendix 3B in relation to this issue is attached.

### Cleansing Statement
