Deep Yellow Limited (ASX:DYL) (**Deep Yellow** or **Company**) confirms that it has today issued 29,032,258 ordinary fully paid shares (**Shares**) under the placement announced on 4 June 2019 to qualified, institutional, sophisticated and professional investors at \$0.31 per Share to raise approximately \$9 million (before costs).
