ISSUE OF SHARES AND INCENTIVE SECURITIES

Deep Yellow Limited (**Deep Yellow** or **Company**) advises that as part of its annual incentive award program and following approval received at the Company's Annual General Meeting the following securities have been issued.

- a) the issue of 431,363 Shares following the vesting of Performance Rights in accordance with their terms;
- b) the issue of 770,000 new Performance Rights to employees pursuant to the Deep Yellow Share Plan;
- c) the issue of 229,884 unlisted options to Non-executive Directors as approved by shareholders at the 2020 AGM; and
- d) the issue of 10,918,707 Loan Shares pursuant to the Deep Yellow Share Plan.

An Appendix 3G in respect of the new Performance Rights and Unlisted Options together with Appendix 2As in respect of the ordinary shares issued are attached for immediate release.

In addition the Company attaches Appendix 3Ys for each of the Directors who received Loan Shares or unlisted options. The issues took place following the 2020 AGM and unfortunately due to an administrative oversight Appendix 3Ys were not filed as required.

The Company advises it is aware of its listing rule obligations in relation to these disclosures and specifically listing rules 3.19A and 3.19B. In this respect the Company makes the following statements about the attached Appendices.

1. The Appendix 3Ys, 2As and 3G are being filed now to correct an administrative oversight;
2. In respect of the 3Ys the Company has informed all Directors of the disclosure requirements set out in the listing rules 3.19, 3.19B and s 205G of the Corporations Act. In addition the Company has adopted a Securities Trading Policy which has been disclosed to the market and outlines the requirements for disclosure and approval of all securities trading; and
3. The Company is confident that the arrangements it currently has in place are adequate and does not believe that any additional steps are required to ensure ongoing compliance with listing rule 3.19B.
