## **QUEENSLAND PERMITS URANIUM MINING**

### **KEY POINTS**

- The Queensland State Government announced today that it would overturn the ban on uranium mining that has been in place since 1989.
- A three-member implementation committee will be convened to oversee the recommencement of uranium mining.
- DYL holds a range of prospective tenements in Queensland's Mount Isa District.
- The current Indicated and Inferred JORC compliant resource in the region is 4.7 million tonnes at 460 ppm U3O8 for 4.8 Mlbs of U3O8.

Advanced stage uranium explorer Deep Yellow Limited (ASX: DYL) today welcomed the decision by Queensland LNP government to once again permit uranium mining in the resource rich state. For your convenience a copy of the Joint Statement by the Premier, The Hon. Campbell Newman, and Minister for Natural Resources and Mines, The Hon. Andrew Cripps, is attached.

DYL's Managing Director Greg Cochran commented "This is at last a major positive step forward for the exploitation of uranium in Queensland – it has been approximately thirty years since uranium was last mined in the state and after many companies have made significant investments in exploration, now is clearly the time to take the next step. Naturally, we look forward to the day when there will be bi-partisan support across all states for uranium mining."

DYL announced in its strategic update in June this year that it will divest its prospective Australian exploration assets in both Queensland and the Northern Territory to focus on its advanced stage Namibian projects. At this stage there is no intent to change this decision although it is likely that there will be additional interest in these assets as a result of today's LNP announcement.

# Queensland to recommence uranium mining

## Monday, October 22, 2012

The State Government has today announced it will convene a three-member implementation committee to oversee the recommencement of uranium mining in Queensland.

Mr Newman said today's announcement followed sustained public debate on uranium mining in Queensland, and strong support for the uranium industry from the Federal Labor Government.

"The Prime Minister Julia Gillard has just been in India selling the benefits of Australianproduced uranium to India, prompting many in the community to ask about the industry's potential in Queensland," Mr Newman said.

"It's been 30 years since there was uranium mining in this State, and in that time Northern Territory, South Australia and Western Australia have carved out successful uranium industries that deliver jobs and prosperity to their regions."

Minister for Natural Resources and Mines Andrew Cripps said with Queensland's known uranium deposits worth an estimated \$10 billion, the industry has enormous potential to support economic growth, particularly in regional North Queensland.

Minister Cripps said the State Government would not consider nuclear energy production or nuclear waste disposal plants in Queensland as part of the recommencement of uranium mining.

Uranium mining has not occurred in Queensland since 1982 and has been effectively prohibited since the election of the Goss Labor Government in 1989.

Exploration for uranium has not been subject to the prohibition and there has been significant continuing interest from the industry in exploring for uranium in the State.

The committee will report to the State Government within three months.
